+ network transparency via search

Joseph S. Nye "The Future of Power"

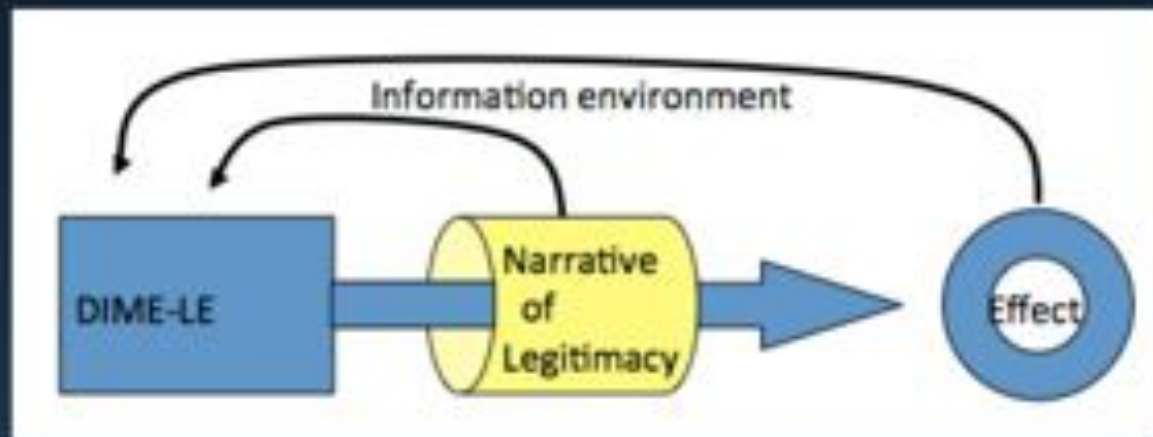
- Commanding change (coerce)
- Setting agendas (persuade)
- Establishing preferences (seduce)

HARD > SOFT > SMART Power

DIME+LE constrained by NARRATIVE

Power is Contextual

Power is constrained or amplified by the context of its exercise, particularly by the perceived legitimacy of its narrative

Non-state Actors

Good Guys

- NGOs, multinationals, international finance, "entrepreneurs/hackers"

Bad Guys

- Terrorists, organized crime, gangs, traffickers, rogue corporations, "hackers"

New Guys

- flash mobs, self organizing systems

Old Guys

- hybrids, proxies, privateers

"Nation" "States"

Westphalian "system"

- Premised on "sovereignty and non-interference"
- maintained by "borders"
- among "imagined communities"

Used geographic bounding of secular states to link political entities/power with particular cultural groups

Platforms

Organizational structures to meet cross-domain demands/needs

- Connecting platforms (eg, supply chains, VOC, BEIC)
- Enabling platforms (eg, financial networks, BE)
- Shaping platforms (eg, NGO campaigns, media, CC)

Platforms have functional boundaries, are subject to network effects, and conform to power laws

Governance ... the power to structure markets to deal with externalities and failures

GaaS

Global Governance as a service

Need to align accountability and enforcement mechanisms with platform/functionality by establishing platform protocols/standards for:

- platform stability (nee security)
- contract enforcement
- sanctions (monopoly on force?)

Need for due process and error correction

Evolving IR Mechanisms

From managing linear process: peace-crisis-war-peace
To managing complex process of 3Cs:

- Cooperation
- Competition
- Conflict

From dominating domains to shaping environments in order to manage transnational and non-state threats

From total war to unrestricted war ... the Chinese way

The Challenge ... to align costs with services

- "LAN" services - police, fire, education
(geographic > property, sales/use taxes)
- "WAN" services - network/platform
governance protocols
 - Who pays for global stability/security?
 - Revenue model? (EU transaction tax)
- Need to allocate profits/redistribute spoils?
 - power law distributions
 - abstraction of "income"

The Future of the "State"

Complex adaptive systems

- Complexity, self-reflectivity, change are key features

Boundaries are mobile, permeable, and more accurately defined in terms of informational reach than of geographic space

Nation state defined by geo-bound culture

Virtual state defined by info-bound culture

Stable change or punctuated equilibrium/phase change?

New Model for Security

A new metaphor -- public health model

- Sanitation
- Innoculation (patching)
- Syndromic Surveillance (anomaly detection)
- Quarantine (circuit breakers)
- Swarm Resources (interdependencies)
- Resilience, recovery (distributed redundancies)

There will be new/unknown pathogens and there will be sickness/attack -- adaptive biological response

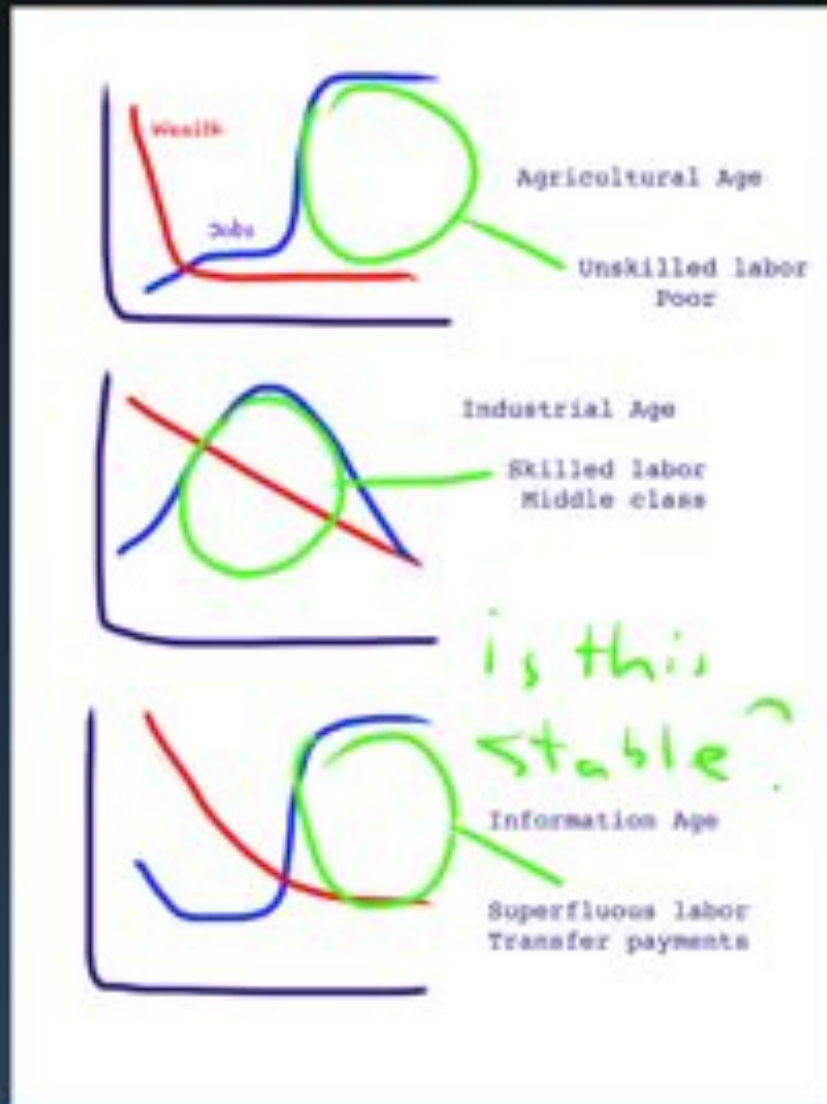
